Terminology

1. Bonus plan a system of premium charging.
2. PAU – paid accounting unit.
3. CAU – current accounting unit.
4. Bonus – a CAU payment made for personal or partner investment involvement.
5. PA – user’s personal account.
6. Payment price – internal calculation price for payment in any currency.
7. Bonus price – internal price for converting to any currency.
8. Unit - UA (unit of account between the company of partners of SWIG, SC Eurasia)
9. Targeted program – a program in “Deposits” folder in the personal account.
10. Pre-IPO equity share – an investment included into the Targeted program.
11. Deposit – a deposit into any Target program or Share.
12. PAI – personally attracted investments from the investors involved.
13. IAP – investments attracted by the partners of your structure.
14. Levels – levels where the investments are found.
15. Status – partner’s status, which depends on amount of work done.
16. Candidate for shareholder (subscriber) – a registered user of a personal account who left his/her personal information – telephone number, name, e-mail.
17. Shareholder (customer) – a registered user, who paid any Targeted program or pre-IPO equity share and verified his/her account.

Income items

- There is no opportunity to take part in acquisition of income, you should accept the terms of the partner's agreement.

Conditions of obtaining qualification

- You should register in a personal account.

Funds withdrawal

- It is impossible to withdraw funds.

Rank «Investor»

Income items

- There is no opportunity to take part in acquisition of income, you should accept the terms of the partner's agreement.

Conditions of obtaining qualification

- A registered user who invested 5 Units or more.

Funds withdrawal

- It is impossible to withdraw funds of partner program.

Rank «Partner»

Income items

- 8% of personal sale in Units;
- 7% of sale at level 2 in Units;
- 3% of sale at level 3 in Units

Bonuses are charged on the Bonus Account.

Conditions of obtaining qualification

- You should register in a personal account and accept the terms of partner's agreement.

Funds withdrawal

- You can participate in the partner program, but you may withdraw bonuses from the Bonus Account only when you invest 50 c.u. (Units) or more.

- 8% of personal sale in Units;

- Required rank: Partner.
- It is necessary to invest 200 c. u. (Units).

 - in order to get 2,6% in Units - personally attract in your 3rd structure the third Consultant;

 - in order to get 3,2% in Units - personally attract in your 1st structure the first Manager;
 - in order to get 3,5% in Units - personally attract in your 2nd structure the second Manager;
 - in order to get 3,8% in Units - personally attract in your 3rd structure the third Manager;

- It is required to attract 4 Managers в 4 structures, where, at least, 2 Managers should be attracted personally, and 2 Managers in depth.
- When you obtain the rank of Leading Manager, your income from level 6 and lower is from 4% to 5% in Units. In order to increase it, you should:
 - in order to get 4,2% in Units - personally attract in your 1st structure the first Leading Manager;
 - in order to get 4,5% in Units - personally attract in your 2nd structure the second Leading Manager;
 - in order to get 4,8% in Units - personally attract in your 3rd structure the third Leading Manager;

Bonuses are charged on the Bonus Account.

Conditions of obtaining qualification

- Required rank: Leading Manager.
- It is necessary to invest 3,500 c. u. (Units).
- It is required to attract 4 Leading Managers in 4 structures, where, at least, 2 Leading Managers should be attracted personally, and 2 Leading Managers in depth.
- When you obtain the rank of Top Manager, your income from level 6 and lower is from 5% to 6% in Units. In order to increase it, you should:
 - in order to get 5,2% in Units - personally attract in your 1st structure the first Top Manager;
 - in order to get 5,5% in Units - personally attract in your 2nd structure the second Top Manager;

- From 6 % to 7% of sale at level 6 and more in Units

Bonuses are charged on the Bonus Account.

Conditions of obtaining qualification

- Required rank: Top Manager.
- It is necessary to invest 8.000 c. u. (Units).
- It is required to attract 4 Top Managers in 4 structures, where, at least, 2 Top Managers should be attracted personally, and 2 Top Managers in depth.
- When you obtain the rank of Advisor of President, your income from level 6 and lower is from 6% to 7% in Units. In order to increase it, you should:
 - in order to get 6,2% in Units - personally attract in your 1st structure the first Advisor of President;
 - in order to get 6,5% in Units - personally attract in your 2nd structure the second Advisor of President;
 - in order to get 6,8% in Units - personally attract in your 3rd structure the third Advisor of President;
 - in order to get 7% in Units - personally attract in your 4th structure the fourth Advisor of President.

- 8% of personal sale in Units;
- 7% of sale at level 2 in Units;
- 5% of sale at level 3 in Units;
- 4% of sale at level 4 in Units;
- 3% of sale at level 5 in Units;
- From 7 % to 8% of sale at level 6 and more in Units

Bonuses are charged on the Bonus Account.

Conditions of obtaining qualification

- Required rank: Advisor of President.
- It is necessary to invest 26,000 c. u. (Units) personally.
- It is required to attract 4 Советников президента в 4 structures, where, at least, 2 Advisors of President should be attracted personally, and 2 Advisors of President in depth.
- When you obtain the rank of President, your revenue from level 6 and lower is from 7% to 8% in Units. In order to increase it, you should:
 - in order to get 7,2% in Units - personally attract in your 1st structure the first President;
 - in order to get 7,5% in Units - personally attract in your 2nd structure the second President;
 - in order to get 7,8% in Units - personally attract in your 3rd structure the third President;
 - in order to get 8% in Units - personally attract in your 4th structure the fourth President.

***Interest from 7% to 8% from level 6 and more is redistributed depending on amount of qualified partners in your first line.
